Medical Supplies for use of OMPH patients

1. The Provincial Government of Oriental Mindoro (PGOM) through the **Trust Fund** intends to apply the **One Million Ninety Thousand One Hundred Sixty Four Pesos and 56/100 Only (Php 1,090,164.56)** (ABC) to payments under the contract for the Project, **“Supply and Delivery of Medical Supplies for use of OMPH patients.”** Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for the Project, **“Supply and Delivery of Medical Supplies for use of OMPH patients.”** Delivery of the goods shall be in accordance with the **Delivery Schedule under Section VI. Schedule of Requirements.** Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least **twenty five percent (25%)** of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).

Bidding is restricted to Filipino citizens/sole proprietorship, partnership or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of w/c grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
