A complete set of Bidding Documents may be acquired by interested bidders from **June 27, 2022 to July 12, 2022** from the Bids and Awards Committee Office and upon payment of a non-refundable fee for the Bidding Documents in compliance with Section 17.4 of RA 9184 and its IRR. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the PGOM, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids in the amount of **Five Thousand Pesos (Php 5,000.00)**.

5. Pre-Bid Conference on **June 30, 2022 at 10:00 a.m.** at BAC Conference Room shall be opened to all interested parties, however only those who purchased the Bidding Documents and invited observers may participate in the discussion at said conference.

6. Bids must be delivered to the address below on or before **July 12, 2022 at 9:30 a.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The PGOM reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
