Drugs and Medicines for OMSDH patients use

1. The Provincial Government of Oriental Mindoro (PGOM) through the **Trust Fund** intends to apply **Two Hundred Thirty Eight Thousand Three Hundred Twenty Nine Pesos and 25/100 Only (Php 238,329.25)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Project, "**Supply and Delivery of Drugs and Medicines for OMSDH patients use.**" Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for the Project, "**Supply and Delivery of Drugs and Medicines for OMSDH patients use.**" Delivery of the goods shall be in accordance with the *Delivery Schedule* under Section VI. *Schedule of Requirements*. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least **twenty five percent (25%)** of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. *Instructions to Bidder (ITB)*.

Bidding is restricted to Filipino citizens/sole proprietorship, partnership or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of w/c grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
