General Merchandise for Distribution to Farmer Beneficiaries under Organic Agriculture Value Chain Development Program of the Provincial Agriculturist's Office

1. The Provincial Government of Oriental Mindoro (PGOM) through the **General Fund** intends to apply **Three Hundred Eighty Three Thousand Pesos Only (Php 383,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Project, **"Supply and Delivery of General Merchandise for distribution to farmer beneficiaries under Organic Agriculture Value Chain Development Program of the Provincial Agriculturist's Office."** Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for the Project, **"Supply and Delivery of General Merchandise for distribution to farmer beneficiaries under Organic Agriculture Value Chain Development Program of the Provincial Agriculturist's Office."** Delivery of the goods shall be in accordance with the Delivery Schedule under Section VI. Schedule of Requirements. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least **twenty five percent (25%)** of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidder (ITB).

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorship, partnership or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of w/c grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
