CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 25 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Senior Citizens Hall at Pinagsabangan I, Naujan, Oriental Mindoro and Construction of Water System at Pinagsabangan I, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount SIX HUNDRED NINETY THOUSAND EIGHTY EIGHT PESOS AND 41/100 ONLY (Php 690,088.41) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
