BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 132, Series of 2020

WHEREAS, there is an infrastructure project funded through the 20% Developmement Fund 2020 to be undertaken by the Provincial Government of Oriental Mindoro for the Improvement of Senior Citizen's Hall at Pinagsabangan I, Naujan, Oriental Mindoro and Construction of Water System at Pinagsabangan I, Naujan, Oriental Mindoro (Improvement of Senior Citizen's Hall includes removal and replacement of hardiflex inside. Installation of ceiling for eaves and tiles and painting of the structure/Construction of 1 unit elevated bestank, 1,000L cap. at Sitio Centro and 1 unit elevated bestank 1,000L cap. at Sitio Ibayo with electric water pump, 2 HP each to be connected from existing deep well to tank to be constructed; note: electrical materials & connection will be charged to barangay);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-132) in PhilGEPS Website on August 04, 2020 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for Improvement of Senior Citizen's Hall at Pinagsabangan I, Naujan, Oriental Mindoro and Construction of Water System at Pinagsabangan I, Naujan, Oriental Mindoro (Improvement of Senior Citizen's Hall includes removal and replacement of hardiflex inside. Installation of ceiling for eaves and tiles and painting of the structure/ Construction of 1 unit elevated bestank, 1,000L cap. at Sitlo Centro and 1 unit elevated bestank 1,000L cap. at Sitlo Ibayo with electric water pump, 2 HP each to be connected from existing deep well to tank to be constructed; note: electrical materials & connection will be charged to barangay);

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

1. RADEL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on August 26, 2020, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on **August 26**, 2020 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by RADEL CONSTRUCTION was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
