CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 21 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and GREAT SWISS METAL BUILDERS CORP. with office address at 2nd Floor, Great Swiss Metal Builders Building, Batangas City represented by ENGR. VICENTE I. CANTOS, President/CEO, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road Gap at Maria Conception, Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FIVE HUNDRED EIGHTY EIGHT THOUSAND FIVE HUNDRED NINE PESOS AND 79/100 ONLY (Php 1,588,509.79) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
