WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Senior Citizen's Building at Malayong, Gloria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION THREE HUNDRED NINETY TWO THOUSAND FIVE HUNDRED FORTY THREE PESOS AND 75/100 ONLY (Php 1,392,543.75) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
