Construction of Multi-Purpose Building at Barangay Calsapa, San Teodoro, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund 2021 intends to apply the sum of Two Million Four Hundred Ninety Seven Thousand Seven Hundred Eighty Six Pesos and 23/100 Only (Php 2,497,786.23) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Multi-Purpose Building at Barangay Calsapa, San Teodoro, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Multi-Purpose Building at Barangay Calsapa, San Teodoro, Or. Mindoro". Completion of the Works is 59 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
