BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 532, Series of 2021

WHEREAS, there is an infrastructure project funded through the 20% Development Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Construction of Multi-Purpose Building at Barangay Calsapa, San Teodoro, Oriental Mindoro (Construction of Covered Court w/ 26m x 14m dimension w/ installation of roof, roof framing and roof accessories; construction of slab(Class B); electrical works; painting works (Steel and Concrete); installation of front design (signage); Rubberized Paint for Basketball Court Lines and Markings installation of fascia frame and fascia cover; Barangay Counterpart-Clearing & Grubbing w/o gutter and downspout);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-121-C) in PhilGEPS Website on October 29, 2021 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Construction of Multi-Purpose Building at Barangay Calsapa, San Teodoro, Oriental Mindoro (Construction of Covered Court w/ 26m x 14m dimension w/ installation of roof, roof framing and roof accessories; construction of slab(Class B); electrical works; painting works (Steel and Concrete); installation of front design (signage); Rubberized Paint for Basketball Court Lines and Markings installation of fascia frame and fascia cover; Barangay Counterpart-Clearing & Grubbing w/o gutter and downspout);

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. GEMWEALTH CONSTRUCTION AND TRADNING CORPORATION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on November 19, 2021, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on **November 19, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by GEMWEALTH CONSTRUCTION AND TRADING CORPORATION was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
