CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 05 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WINKONSTRUCT ENTERPRISES with office address at Unit 17, Filipiniana Complex, Calapan City, Oriental Mindoro represented by ENGR. LOUIGI ALMOND P. GAYUTIN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Multi Purpose Building at Barangay Bigaan, San Teodoro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FOUR HUNDRED NINETY SIX THOUSAND ONE HUNDRED TWENTY ONE PESOS AND 14/100 ONLY (Php 2,496,121.14) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
