## **CONTRACT AGREEMENT**

THIS AGREEMENT, made this \_\_\_\_\_\_\_\_ between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ZOE BUILDERS AND SUPPLIES COMPANY with office address at Sta. Isabel, Calapan City, Oriental Mindoro represented by LEODEGARIO A. GUTIERREZ, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Multi-Purpose Building at Sta. Rosa II, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FOUR HUNDRED FIFTY EIGHT THOUSAND TWO HUNDRED THIRTY THREE PESOS AND 26/100 (Php 2,458,233.26) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
