CONTRACT AGREEMENT

THIS AGREEMENT, made this AUG 10 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 811 TRADING AND CONSTRUCTION with office address at 9 Palayan St., Paclasan, Roxas, Oriental Mindoro represented by ENGR. ARMIN C. SUZARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Villa Pag-asa, Bansud, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY SIX THOUSAND THREE HUNDRED SEVEN PESOS AND 07/100 ONLY (Php 996,307.07) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
