YLAGAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Senior Citizen's Building at Anoling, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION THREE HUNDRED NINETY SIX THOUSAND SIX HUNDRED EIGHTY SIX PESOS ONLY (Php 1,396,686.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
