CONTRACT AGREEMENT

THIS AGREEMENT, made this AUG 20 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **GEMWEALTH CONSTRUCTION AND TRADING CORPORATION** with office address at Lapu-lapu, Ibaan, Batangas represented by **CLYDE E. SOTTO**, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road at Banilad, Pinamalayan, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED NINETY THOUSAND EIGHT HUNDRED FIFTY FOUR PESOS AND 62/100 ONLY (Php 990,854.62)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
 1. Equipment Utilization Schedule
