CONTRACT AGREEMENT

THIS AGREEMENT, made this AUG 2 3 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Calocmoy, Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY FIVE THOUSAND SIXTY PESOS AND 03/100 ONLY (Php 995,060.03) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
