CONTRACT AGREEMENT

THIS AGREEMENT, made this AUG 23 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **RJJJ ENGINEERING SERVICES** with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by **JOHN CROMWELL D. RECTO**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road at Bayuin, Socorro, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED NINETY TWO THOUSAND NINE HUNDRED SIXTY SEVEN PESOS AND 14/100 ONLY (Php 992,967.14)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
