CONTRACT AGREEMENT

THIS AGREEMENT, made this AUG 23 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **811 TRADING AND CONSTRUCTION** with office address at 9 Palayan St., Paclasan, Roxas, Oriental Mindoro represented by **ENGR. ARMIN C. SUZARA**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road at Malo, Bansud, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED EIGHTY SEVEN THOUSAND NINE HUNDRED FIFTY FOUR PESOS AND 05/100 ONLY (Php 987,954.05)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
