## **CONTRACT AGREEMENT**

THIS AGREEMENT, made this AUG 2 0 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WEBUILD CONSTRUCTION with office address at Bagumbayan, Roxas, Oriental Mindoro represented by CHRISTOPHER Y. CARVAJAL, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Proper Tiguisan, Bansud, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY THOUSAND TWO HUNDRED FIFTY SIX PESOS AND 11/100 ONLY (Php 990,256.11) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
