THIS AGREEMENT, made this ______AUG 2 0 2021 ______ between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 876 CONSTRUCTION & SUPPLY with office address at Malamig, Calapan City, Oriental Mindoro represented by ROBERTO B. YLAGAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Mirayan, Gloria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY SEVEN THOUSAND TWO HUNDRED ONE PESOS AND 78/100 ONLY (Php 997,201.78) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
