CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 13 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and GREEN ISLAND ENTERPRISES with office address at Maligaya, Gloria, Oriental Mindoro represented by JOANNE D. ENRIQUEZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of 1 Classroom Building at Formon NHS, Formon, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED SEVENTY FIVE THOUSAND SEVEN HUNDRED FORTY SIX PESOS AND 43/100 (Php 1,475,746.43) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
