DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and GREEN ISLAND ENTERPRISES with office address at Maligava. Gloria, Oriental Mindoro represented by JOANNE D. ENRIQUEZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of 1 Classroom Building at Formon NHS, Formon, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED SEVENTY FIVE THOUSAND SEVEN HUNDRED FORTY SIX PESOS AND 43/100 (Php 1,475,746.43) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
