CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 10 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SOSEP BUILDERS with office address at Campaasan, Bulalacao, Oriental Mindoro represented by ENGR. ERNESTO C. VILLAS, JR., Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of 1 CL in Buong Lupa HS, Gloria, Oriental Mindoro and Repair of Classroom at Banus ES, Banus, Gloria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION EIGHT HUNDRED SEVENTY NINE THOUSAND FIVE HUNDRED FIFTY FOUR PESOS AND 55/100 ONLY (Php 1,879,554.55) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
