CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 1 3 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and CMSEL CONSTRUCTION AND DEVELOPER with office address at Masipit, Calapan City, Oriental Mindoro represented by MARIETA T. MADERAZO, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Classroom Building at San Andres Elementary School, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED SEVENTY ONE THOUSAND TWO HUNDRED SIXTY NINE PESOS AND 60/100 ONLY (Php 1,471,269.60) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
