CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 16 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **SOSEP BUILDERS** with office address at Campaasan, Bulalacao, Oriental Mindoro represented by **ENGR. ERNESTO C. VILLAS, JR.**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Repair of Covered Court at Pedro Panaligan NHS, Comunal, Calapan City, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **SEVEN HUNDRED NINETY SEVEN THOUSAND FOUR HUNDRED SIXTY TWO PESOS AND 84/100 ONLY (Php 797,462.84)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
