DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and LAS MINAS DE ORO CONSTRUCTION with office address in Sta. Maria Village, Calapan City, Oriental Mindoro represented by EVELYN A. ABAS, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Senior Citizens Building at G. Antonino, Gloria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO HUNDRED NINETY EIGHT THOUSAND FIVE HUNDRED THIRTY NINE PESOS ONLY (Php 298,539.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
