CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 20 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **MDH CONSTRUCTION** with office address at #327 College Road, Brgy. 58, Pasay City, Metro Manila represented by **ARCHIE LEE HUEVOS**, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road at Managpi, Calapan City, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED EIGHTY EIGHT THOUSAND FIVE HUNDRED TWENTY SEVEN PESOS AND 02/100 ONLY (Php 988,527.02)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
