## **CONTRACT AGREEMENT**

THIS AGREEMENT, made this \_\_\_\_\_\_\_ between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MDH CONSTRUCTION with office address at #327 College Road, Brgy. 58, Pasay City, Metro Manila represented by ARCHIE LEE HUEVOS, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Managpi, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY EIGHT THOUSAND FIVE HUNDRED TWENTY SEVEN PESOS AND 02/100 ONLY (Php 988,527.02) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
