CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 0 1 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MARCPHIL CONSTRUCTION with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARCIANO M. DIMAPILIS, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of ABC Hall at Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION THREE HUNDRED SEVENTY EIGHT THOUSAND TWO HUNDRED NINETEEN PESOS ONLY (Php 1,378,219.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements

 - 2. Manpower Utilization Schedule
 - 3. Construction Method
 - 4. Construction Schedule and S-Curve
