DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas, Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Classroom Building at Bait ES, Panaytayan, Mansalay, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FIVE HUNDRED NINETY THOUSAND NINE PESOS ONLY (Php 1,590,009.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
