CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 23 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 876 CONSTRUCTION & SUPPLY with office address at Malamig, Calapan City, Oriental Mindoro represented by ROBERTO B. YLAGAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Senior Citizen's Building/ Women's Building at Zone IV, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION ONE HUNDRED NINETY EIGHT THOUSAND FOUR HUNDRED SEVEN PESOS AND 56/100 ONLY (Php 1,198,407.56) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
