CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 24 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WINKONSTRUCT ENTERPRISES with office address at Unit 17, Filipiniana Complex, Calapan City, Oriental Mindoro represented by ENGR. LOUIGI ALMOND P. GAYUTIN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Multi- Purpose Building at Brgy. Matungao, Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND NINE HUNDRED TEN PESOS AND 48/100 ONLY (Php 1,988,910.48) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
