San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Renovation of Bagong Lipunan School Building Type II at Joaquin G. Hernandez ES, Sta. Isabel, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION SEVEN HUNDRED EIGHTY THREE THOUSAND TWENTY EIGHT PESOS AND 06/100 ONLY (Php 1,783,028.06) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
