CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 23 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas, Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of 2nd PMFC Headquarters at Bagong Bayan II, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FOUR HUNDRED EIGHTY FIVE THOUSAND FOUR HUNDRED THREE PESOS AND 40/100 ONLY (Php 2,485,403.40) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
