DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas. Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer. hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Lisap, Bongabong,, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED EIGHTY THOUSAND FORTY THREE PESOS AND 90/100 ONLY (Php 1,480,043.90) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
