THIS AGREEMENT, made this OCT 0 1 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MARCPHIL CONSTRUCTION with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARCIANO M. DIMAPILIS, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at San Isidro, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED EIGHTY THOUSAND FIVE HUNDRED TWENTY ONE PESOS AND 36/100 ONLY (Php 1,480,521.36) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
