CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 01 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **MARCPHIL CONSTRUCTION** with office address at San Aquilino, Roxas, Oriental Mindoro represented by **MARCIANO M. DIMAPILIS**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road at Sagana, Bongabong, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION FOUR HUNDRED SEVENTY EIGHT THOUSAND ONE HUNDRED FOURTEEN PESOS AND 56/100 ONLY (Php 1,478,114.56)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
