CONTRACT AGREEMENT


THIS AGREEMENT, made this OCT 0 1 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MARCPHIL CONSTRUCTION with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARCIANO M. DIMAPILIS, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Sagana, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED SEVENTY EIGHT THOUSAND ONE HUNDRED FOURTEEN PESOS AND 56/100 ONLY (Php 1,478,114.56) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
