CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 24 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WEBUILD CONSTRUCTION with office address at Bagumbayan, Roxas, Oriental Mindoro represented by CHRISTOPHER Y. CARVAJAL, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Bongabong Youth Center at Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND SEVEN HUNDRED SIXTY ONE PESOS AND 12/100 ONLY (Php 1,988,761.12) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
