## CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 0 1 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WTL CONSTRUCTION with office address Manilo St., Mansalay, Oriental Mindoro represented by RENATO T. DE LARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Cabugao, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION THIRTY EIGHT THOUSAND EIGHT HUNDRED TEN PESOS AND 24/100 (Php 2,038,810.24) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
