CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 24 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Classroom at San Teodoro NHS- Tacligan Extension, San Teodoro, Oriental Mindoro and Completion of SSG Office at San Teodoro NHS, Bigaan, San Teodoro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE HUNDRED FIFTY THREE THOUSAND EIGHT HUNDRED TEN PESOS AND 29/100 ONLY (Php 553,810.29) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
