CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 19 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **MARCPHIL CONSTRUCTION** with office address at San Aquilino, Roxas, Oriental Mindoro represented by **MARCIANO M. DIMAPILIS**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Repair of Road at San Rafael, Roxas, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED FIFTY SIX THOUSAND THREE HUNDRED TWENTY PESOS AND 06/100 ONLY (Php 956,320.06)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
