DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and B5 BUILDERS & SUPPLIES with office address at Libis, Calapan City, Oriental Mindoro represented by BERNARDO O. APACIBLE, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair/ Rehab of Senior Citizen's Building at Urdaneta, Victoria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount EIGHT HUNDRED NINETY FOUR THOUSAND FIVE HUNDRED EIGHTY SEVEN PESOS ONLY (Php 894,587.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
