CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 0 8 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **876 CONSTRUCTION & SUPPLY** with office address at Malamig, Calapan City, Oriental Mindoro represented by **ROBERTO B. YLAGAN**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Road at Malamig, Gloria, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED SEVENTY ONE THOUSAND FOUR HUNDRED EIGHTY FOUR PESOS AND 21/100 ONLY (Php 971,484.21)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - D. Performance Security
 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
