CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 02 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **B5 BUILDERS & SUPPLIES** with office address at Libis, Calapan City, Oriental Mindoro represented by **BERNARDO O. APACIBLE**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Repair of Classroom at Victoria Central School, Victoria, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **FOUR HUNDRED NINETY SIX THOUSAND EIGHT HUNDRED EIGHTY THREE PESOS AND 43/100 ONLY (Php 496,883.43)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
