San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Barangay Road at Purok 5, Concepcion, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY ONE THOUSAND ONE PESOS AND 04/100 (Php 991,001.04) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
