OCT 1 1 2021 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas, Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road Leading to High School at Balatasan, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY SEVEN THOUSAND FIVE HUNDRED THIRTY TWO PESOS AND 73/100 ONLY (Php 987,532.73) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
