DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SGDG CONSTRUCTION AND SUPPLIES with office address Sapul, Calapan City, Oriental Mindoro represented by DEMETRIUS H. GOZAR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Protection Dike at Malapad, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED EIGHTY ONE THOUSAND NINETEEN PESOS AND 32/100 ONLY (Php 1,981,019.32) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
