CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 08 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MHARPHY CONSTRUCTION AND SUPPLY with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARIO S. PEREZ, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Bonbon, Mansalay, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FIFTY FOUR THOUSAND FOURTEEN PESOS AND 25/100 ONLY (Php 2,054,014.25) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
