CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 08 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RM SESCAR ENTERPRISES with office address at San Mariano, Roxas, Oriental Mindoro represented by RIZALITO M. SESCAR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Multi- Purpose Hall at San Mariano, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION NINE HUNDRED NINETY FOUR THOUSAND SIX HUNDRED EIGHTY ONE PESOS AND 77/100 (Php 2,994,681.77) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
